Committee Goals for 2007 (what did the committee plan to accomplish in 2007):

- 1. Continue to support the project "Creation of a Prioritization Model to Identify Weeds of Global Significance." Final in-house reviews completed, copyright permissions obtained, and fact sheets ready to be placed on WSSA web site. Work was continued by APHIS but fact sheets are yet to be released for web use.
- 2. The data base for "Invasive Weeds" researchers at the Center for Invasive Plant Management and within WSSA established during 2005 was continued and updated during 2007. Look into the possibility of placing this database on the WSSA web site or at least a link to CIPM so that the list is more accessible.
- 3. Creation of Subject Matter Expert position. The position was created by the WSSA Board and a person, Dr. Steve Dewey, was selected and hired to fill this position during a portion of 2007. The work that Dr. Dewey is doing has been well received and he has actively utilized WSSA experts to meet his responsibilities.
- 4. Continue to review weed science related federal legislation and make recommendations regarding changes in any legislation relating to noxious or invasive weeds, including non-weed laws where noxious and invasive weeds are or could adversely affect other organisms; encourage development of noxious weed programs and regulations; serve in an advisory capacity to USDA-APHIS, PPQ; and serve in an advisory capacity to federal agencies concerning biological and ecological characteristics and control methodology of noxious and invasive weeds.
