<u>Contractor Objectives:</u> 1) Increase subscriptions to the journal *Invasive Plant Science and Management*, particularly focusing on individual subscribers; and, as a result, 2) increase membership in WSSA.

September 2008

- Investigated other state weed control association newsletters
- Compiled six-month work plan
- Took IPSM promotional materials to North American Weed Management Association annual meeting in Billings, MT.
- Investigated advertising in Wildland Weeds
