2011 Summary of Activities

What were the committee's goals for 2012?

Review and publish submitted manuscripts in a competent and timely manner.

List the committee's accomplishments in 2012:

In 2012, 206 manuscripts were submitted to Weed Science, which was down from the 230 submitted in 2011. The average time from submission to first decision was 50 days in 2012, a slight improvement over the 52 day turnaround in 2011.

Weed Science journal continues to have high international stature. The subject matter of manuscripts was Weed Biology and Ecology (48%), Weed Management (24%), Physiology/Chemistry/Biochemistry (23%), Soil/Air/Water (3%), and Special Topics/Rapid Communication/Invited/Symposium (2%). There was a 73% increase in Physiology/Chemistry/Biochemistry submissions in 2012 over 2011. This can be attributed to increased submissions in the area of herbicide resistance.

The manuscript acceptance rate in 2012 was 66%, similar to the 68% in 2011. The impact factor for Weed Science was 1.733 in 2011 up from 1.451 in 2009, a 19% increase. The five-year average for the impact factor is 1.696. In comparison, the impact factor for Weed Research and Pest Management Science in 2011 was 1.924 and 2.251, respectively. All accepted manuscripts are now posted on our website prior to printing. This speeds up the information dissemination process considerably.

Weed Science published a special issue in 2012 entitled Herbicide Resistant Weeds from a WSSA USDA-APHIS collaboration to produce a white paper on the status of herbicide resistance and recommendations to manage herbicide resistance.

Manuscript submission instructions. In 2012, a template was added to the website to assist authors in assembling manuscripts for the journal.
