#### 2010 Summary of Activities

Advertisements were placed in several newsletters, including WSSA, ASPP, ASA, APMS, the Regional Weed Science Society Newsletters as well as Weed Technology and the Journal of Natural Resources and Life Sciences. A personal letter containing the grant announcement was sent to approximately 400 WSSA Educators in September 2011, this was followed with a Society-wide e-mail announcement. It's been a bit of a slow year with 8 grant applications received, however one was from a graduate student; it's the unanimous judgment of this committee that graduate students do not qualify for this undergraduate research award. Applications were reasonably well distributed across the Society and included universities in Colorado (2), California, Hawaii, Idaho, Kansas, New York, and Virginia.

#### What were the committee's goals for 2010?

The key objective for 2011 was to announce the availability of this research award, accept grant proposals, rank those proposals and select winning applications. Announcement of winning applications is planned for the 2012 WSSA National Meeting Awards Ceremony.

#### List the committee's accomplishments in 2011:

We will award 7 undergraduate research grants and encouraged a working relationship between these students and their faculty sponsors.

The grant announcement and directions to submitters was posted and a link forwarded to the membership via the list serve.

# How much funds were requested? How much was spent?

We have Board authorization to fund 8 awards (\$8,000), these funds will be distributed in 2011.

# What was the impact of the committee activities/accomplishments on the following: membership, publication, policy, legislation, and/or education?

This award's goal is to introduce Weed Science research to undergraduates and create or deepen relationships between these students and Weed Science faculty. In this way, this grant hopes to increase membership through hands-on education and recruitment.
