What is needed to further the goals of the committee/project?

In 2006, the committee rewrote our nomination package. Our goal was to make the nomination package less burdensome to prepare and review and to create a format that highlights the qualifications of the nominee. In 2008, the criteria for the award was clarified and used in this year's selection of the award winner. This resulted in much more consist rankings among the nominated candidates. The criteria for the award are listed below. It emphasizes the idea of creative, innovative and impact and does not specifically indicate that this had to be over a career, but the implication under the first bullet is that to achieve this would take more than a couple of publications. No further action is needed as the criteria and process seems to be functioning well.

This award is for members of the WSSA who have conducted a **creative** and **innovative research** with a **significant impact** on the scientific concepts or practices of Weed Science. This award is established to recognize outstanding contributions to both applied and basic weed science research. The successful should:

- Establish documented record for significant accomplishments in research as reflected by regular publication in refereed journals or comparable publications.
- Demonstrate independence, originality and creativity in basic or applied research contributions in weed science.
- Provide evidence of significant impact in addressing an applied problem or to the basic knowledge within the discipline of weed science, with recognition both nationally and internationally.
